Frequently Asked Questions

Q. What is the IBA Self Study Program?

A. It is a way for students to complete AIB courses any time of the year, on their own schedule, without attending formal classes.

Q. How long will it take to receive course materials?

A. Students will receive their course materials within 14 days of the receipt of their enrollment form.

Q. How long does it take to complete a self study course?

A. Once enrolled, course work can begin anytime with a maximum of six months allowed to complete a course.

Q. What is the faculty advisor's role?

A. Even though students work independently, assistance is available from an IBA faculty advisor who is responsible for grading course exams and provides assistance with course material and questions.

Q. How will students be notified when the course is completed?

A. Students will receive a grade report and a certificate of completion within 14 days of their faculty advisor submitting the grade to the IBA.
